Shaun Namarnyilk

Shaun Namarnyilk, born 1979, is a Burlarldja man from Gunbalanya, Western Arnhem Land, the son of Rita Nadjongorle and Bundy Namarnyilk. Shaun is an experienced artist, tour guide, musician, and storyteller. His evolving artistic aesthetic draws inspiration from the ancient rock art stories and styles found at Injalak Hill and other significant sites in the region.

Shaun's previous work as a ranger caring for the Stone Country of West Arnhem Land gave him privileged access to remote and inaccessible rock art sites. This experience deeply informs his work. Inspired by the knowledge and aesthetics of his ancestors, he creates remarkable contemporary paintings that explore a wide range of subjects. These include traditional knowledge, sacred spirit beings, and current affairs, such as the impact of the coronavirus pandemic on the Gunbalanya community and the unique challenges and benefits of living in a remote location.

To achieve the visual textures of ancient rock art, Shaun mixes colored pigments and ochres, creating backgrounds that reflect the rock surfaces themselves. He skillfully employs the West Arnhem 'x-ray style' technique, leaving his canvases exposed to the elements and building layers to give his artworks a weathered, timeless quality.

Shaun's grandfathers include the notable artists Djawida Nadjongorle, Spider Namirrikki, and Jimmy Namarnyilk. His rich artistic lineage further strengthens his connection to the cultural heritage of the region.

In November 2023 Colin Biggers & Paisley participated in the United Nations' 16 Days of Activism for the Elimination of Violence Against Women with the theme: UNITE! Invest to prevent violence against women and girls.

Over 16 days we showcased our pro bono and responsible business partnerships with not-for-profits and community clients working on the front line to assist vulnerable women and girls. We shared internal communications with all staff and external social media posts to raise awareness and share the actions we are taking to create a world free of violence towards women. Each communication spotlighted one or more of our community partners, including the International Women's Development Agency, Women's Legal Service NSW, YouthLaw, Refugee Legal and RizeUp Australia.

The Colin Biggers & Paisley Foundation partnered with RizeUp Australia as our Major Charity partner. Over the last two years, we raised and donated over \$120,000 and provided 75 hours of pro bono support to RizeUp.

Colin Biggers & Paisley staff were also involved in RizeUp's Homes Volunteer program, assisting with setting up 17 homes for families fleeing Family and Domestic Violence; and RizeUp's Annual Christmas Toy Appeal by purchasing gifts for children in need.



INITIATIVE

Victim-Survivors of Violence Project

The Colin Biggers & Paisley Foundation's Victim-Survivors of Violence Project is an initiative designed to address the critical legal needs of women and children affected by gender-based violence. Partnering with Women's Legal Service NSW, Women's Legal Service Victoria, and YouthLaw Victoria, the project provides specialised pro bono legal support and representation, particularly for victims of domestic, family, and sexual violence in NSW and Victoria.

Through substantial pro bono hours, advocacy for policy reform, and financial support, Colin Biggers & Paisley has significantly improved access to justice for many women, children and youth affected by violence. The project's holistic approach not only addresses immediate legal needs but also contributes to long-term systemic change, fostering a more just and equitable society.

81 victim-survivors provided with legal advice, and representation

1,278 pro bono hours contributed, including comprehensive casework, gathering evidence, drafting submissions and facilitating clients' navigation of the justice system.

Women's Legal Service NSW

Women's Legal Service NSW is an independent non-profit organisation which provides a voice for women in NSW, and promotes access to justice, particularly for women who are disadvantaged by their social and economic circumstances.

Since 2015 Colin Biggers & Paisley has provided Women's Legal Service NSW with a range of in-kind, pro bono, legal research and financial support. Our partnership with Women's Legal Service NSW brings increased capacity for sector advocacy, client representation and access to justice for women in need.

"Colin Biggers & Paisley have provided invaluable research assistance to inform Women's Legal Service NSW and broader sector advocacy. This has strengthened the supports offered to victim-survivors of gender-based violence through the NSW Victims Support Scheme. "My name is Layla Chahrouk and I graduated from high school whilst simultaneously undertaking a traineeship with Colin Biggers & Paisley. I completed this School-Based Traineeship by combining work and training with a Certificate III in Business, which also counted towards my HSC. Overall, the best aspect of working as a trainee was being immersed in a whole new environment as opposed to my usual high school lifestyle.

School-Based Apprenticeship and Traineeship Program

This mentoring program developed by Colin Biggers & Paisley in collaboration with Chifley College - Shalvey Campus and the NSW Department of Education aims to empower students, build confidence, develop resilience, and raise aspirations. The program targets Year 10 students at Shalvey Campus, a public high school in western Sydney where many students face intergenerational disadvantage and complex social issues.

The Mentoring Program pairs 15 Colin Biggers & Paisley volunteers with 15 students for five sessions throughout the school year. Each session, spanning two hours, focuses on introducing students to the corporate environment, offering insights into career pathways, and providing guidance on academic and professional development. The program also has a significant impact on the volunteer mentors, providing them with opportunities for personal growth, leadership development, and improved coaching skills.

Youthlaw

"As part of the graduate program, I completed a 5 month pro bono secondment rotation with Youthlaw three days a week. I was involved in the Legal Pod Program and assisted young clients with various civil matters such as fines, debts, Victorian Civil & Administrative Tribunal, and freedom of information requests. Many Youthlaw clients had experienced the out-ofhome care system including residential or foster care. It was wonderful to work with vulnerable young people and help them to resolve their burdensome legal matters. It was rewarding to know that our work is helping clients to move on with their lives. My experience was eyeopening and exposed me to a different side of the law and how I could use my legal skills to help others."

Youthlaw is a community legal centre based in Carlton, Victoria that provides legal advice and representation to young people under the age of 25 all across the state.

Colin Biggers & Paisley seconds a lawyer to coordinate and run Youthlaw's innovative 'Legal Pod Program' which provides legal support for young people who have exited the out-of-home care system, including foster care, residential care and kinship care. Transition to independent living can be difficult for many young people, so each Legal Pod client is assigned a small team of lawyers for a period of up to three years.

We also provide ongoing legal advice and representation to young people who have experienced family, domestic and sexual violence as victims of crime.





Marrickville Legal Centre – Youth Project



"Colin Biggers & Paisley's commitment to early intervention is reflected in support of community legal education projects such as a workshop one of their lawyers ran for over 100 girls on bullying. The girls engaged with the case studies and were empowered by relating it to their own lived experience which leads them to be mindful of the broad impacts of online behaviour.

"With the Colin Biggers & Paisley secondees' assistance, we've also created a series of short, 15 second videos to bust some bullying misconceptions via social media. This series will be launched for Youth Week. We would not have been able to work on these initiatives with our limited resources.

"Lastly, court users who have not received legal help prior to arriving at court receive on the spot assistance. Secondees provide advice and representation, promoting better outcomes for the community. Guilty defendants who take responsibility receive a more lenient sentence by entering appropriate pleas and enrolling in rehabilitation. The risk of reoffending is significantly reduced."

Marrickville Legal Centre is a not-for-profit community legal centre based in Sydney's inner-west, serving people all across NSW. Many clients are young people who lack experience in dealing with everyday matters.

Dedicated Colin Biggers & Paisley lawyers and secondees assist with a range of different matters including car accidents, traffic fines, underpayments at work, consumer disputes, discrimination, identity fraud and victims' compensation.

With Colin Biggers & Paisley's pro bono support, access to justice is enhanced through timely, professional, and non-judgmental advice. In addition to enabling the service to provide ongoing representation, the support prevents legal problems from developing by drawing on Colin Biggers & Paisley's extensive expertise and experience.

CANDICE HUGHES Principal Solicitor, YFS Legal In Australia only 4% of First Nations adults have a will, compared to 55% of the general population. Unfortunately, over 70% of disputes regarding probate involve First Nations' Australians.

In November 2023, we continued to run our successful pro bono First Nations' Wills Clinic programs across Victoria and Queensland. Approximately 30 Indigenous Elders were assisted with information about and drafting of their wills and end of life documents, in partnership with 'Nairm Marr Djambana' in Frankston, Victoria and 'YFS Legal' in Inala, South Brisbane.

Weave is a community-based organisation with over 45 years of 'walking alongside' their clients in Sydney's Redfern, Waterloo, La Perouse and Woolloomooloo communities. Weave provides wrap around casework support, assisting young people and families to thrive in areas of housing, employment, education, mental health and connecting to culture. Reducing the overrepresentation of Aboriginal young people in the criminal justice system is a key priority for Weave. Weave supports around 2,000 people per year, with over 70% of participants identifying as Aboriginal.

The Colin Biggers & Paisley Foundation's partnership with Weave covers a wide range of legal matters, including reviewing leases, policies, funding contracts, trademarks, insurance, risk, privacy, employment law and complex issues of consent. Colin Biggers & Paisley staff are welcomed at Weave community events, and they in turn have joined Colin Biggers & Paisley at our key events.

They offer a range of services and opportunities to Indigenous and non-Indigenous community members, including Worn Gundidj at Tower Hill (cultural tours, programs, events and programs), Worn Gundidj Bush Foods (a range of bush foods, from grains to ice cream) and Worn Gundidj Plant Nursery.

Colin Biggers & Paisley has worked alongside Worn Gundidj to help it achieve its objective to grow, become self-sustaining and independent of grant funding. Colin Biggers & Paisley Partner Morgan Lane and our Corporate and Commercial team have assisted Worn Gundidj with a range of legal matters including drafting service agreements, terms and conditions, e-commerce and Working With Children Check appeals.



INITIATIVE

Ngalaya Ball and First Nations Law Awards Sponsorship

Ngalaya is the peak body for First Nations lawyers and law students across NSW/ACT, with the mission to support and grow the next generation of First Nations law makers. Since 2019, Colin Biggers & Paisley Foundation has proudly supported Ngalaya with its student cadetship program and student sponsorships.

In October 2023, the Colin Biggers & Paisley Foundation supported the Ngalaya Ball and First Nations Law Awards by sponsoring the 'First Nations Senior Law Student of the Year Award'. This award is for current First Nations law students in their 4th or later year of a combined law degree; or 1.5 years or later of a 3 year law degree, living and studying in NSW/ACT. The 2023 Award recipient was Sharleigh Crittenden. Sharleigh is a Wiradjuri woman in her final year of a combined Bachelor of Criminology and Criminal Justice/Bachelor of Laws, and is an Indigenous Research Cadet in the Faculty of Law and Justice at UNSW, Sydney.

The Ngalaya and Colin Biggers & Paisley First Nations Law Scholarship is available to Aboriginal and Torres Strait Islander law students studying in NSW and the ACT. The scholarship was established in 2021 by Ngalaya, and is funded by Colin Biggers & Paisley. Luca Sawyer, a 4th year Wiradjuri woman studying at UNSW received the Scholarship in 2024.

Since 2022, the Colin Biggers & Paisley Indigenous Cadetship Program has helped increase employment of First Nations' people within the field of law and business services. The cadetship program supports our commitment to provide equitable career opportunities and actively promote the participation of Aboriginal and Torres Strait Islander people within our business.

Cadets are offered part-time employment for the duration of their law degree and the opportunity to build new skills, knowledge and experience, while gaining a greater understanding of our clients and their businesses. We support our cadets as they complete their studies by offering, formal mentoring, professional development, networking opportunities and conference attendance.

In 2023, we welcomed our second cadet, Grace Slatyer. Grace is a proud Aboriginal woman who originates from the Juru mob in Queensland. She currently lives on Dharug Country (NSW) and is in her final year as an undergraduate Law student at Macquarie University.

Arts Law Centre — Artists in the Black and 'Adopt a Lawyer'



The Arts Law Centre of Australia is a national not-forprofit community legal centre for the arts, providing advice, resources and training to artists and arts organisations on a range of legal and commercial matters. Arts Law Artists in the Black provides legal support specifically for First Nations' artists and not-for-profit arts organisations, usually via community outreach to remote communities. Through the initiative, volunteer lawyers provide in-person pro bono legal advice, assistance, and representation on a range of legal issues, including copyright, intellectual property, contracts, licensing agreements, defamation, arts funding and estate planning.

In May 2024, Andrew Logie-Smith, Partner, travelled to Wurrumiyanga, Bathurst Island, to meet with the artists, art centre managers and arts workers at Ngaruwanajirri Art Centre, Bima Wear and Tiwi Designs. He visited art centres on Melville and Bathurst Islands with the Arts Law Centre's Artists in the Black program.

The artists Andrew met with work across a broad range of practices reflecting the Tiwi Islands' rich cultural and artistic history - painting, mainly with ochre, carving, weaving, print making, textile printing and fashion. The strength of Tiwi culture is reflected in there art centres from a population of fewer than 3,000 people.

The fundamental importance of art centres and women's centres where art is practiced, as community hubs and as economic centres for their communities was a highlight.

Adopt a Lawyer: Injalak Arts & Crafts Aboriginal Corporation

"In May 2024, I spent four days in the

Northern Territory providing legal advice to First Nations artists at Injalak Art Centre through Arts Law Artists in the Black and our Adopt a Lawyer partnership. Injalak Art Centre is in Gunbalanya, a large remote town of around 1,200 people in Arnhem Land, about 300km east of Darwin. The Centre supports a diverse range of arts practices and through this outreach clinic I was able to directly support First Nations artists by providing access to legal assistance in their community.

The artists were particularly interested in talking about copyright and licensing, along with learning more about the importance of wills, and specifically how to ensure their will protected the copyright and royalties of their artworks after they pass away. As First Nations artwork becomes increasingly popular and prolific, it is vital that artists understand their rights and feel empowered to exercise them."

Adopt a Lawyer: Hermannsburg Potters Aboriginal Corporation

"In July 2023 I was fortunate to support Artist in the Black outreach clinics to remote and regional communities in the Northern Territory. We visited Bindi Mwerre Art Centre in Alice Springs, Walkatjara and Maruku Arts Centres near Uluru and the Hermannsburg Potters who are also Colin Biggers & Paisley 'Adopt a Lawyer' partners. At each art centre we connected with the artists and the staff. We provided advice on estate issues, the Public Trustee, prepared wills and reviewed existing wills. We also spoke to artists about their intellectual property rights, licensing, copyright issues, consignments of art works to galleries, royalty payment structures and other legal matters.

"It was such a pleasure to have the opportunity to sit with the artists while they worked and to discuss their wishes and what it meant for them to be able to provide for their families during their lifetime and after they have passed."

The Hermannsburg Potters are a dedicated group of Western Arrarnta artists creating vibrant handmade ceramic pots that encompass collective and individually lived histories in their distinct Country. The Hermannsburg artists continue a 40-year legacy, sculpting and painting their visual histories and contemporary settings that speak to their cultural beliefs, traditions and values.

Since 2017, the Colin Biggers & Paisley Foundation has worked closely with Hermannsburg Potters as a key partner through the 'Adopt a Lawyer' program. Our lawyers have provided Hermannsburg Potters with advice on intellectual property including licensing and copyright, contractual matters relating to consignment of art works to galleries, constitutional advice to the organisation and legal advice and drafting of wills for the potters to ensure their wishes are followed on their passing.

Colin Biggers & Paisley is also honoured to share Hermannsburg potter Anita Ratara's artwork entitled *Thepa Ntjaarra (Many Birds)* in the publication of our current Innovate Reconciliation Action Plan.

Fundraising: Colin Biggers & Paisley Graduate Teams

Colin Biggers & Paisley Graduate teams from our Brisbane, Sydney and Melbourne offices hold an annual fundraising challenge to raise funds for our major charity partner. Through a series of events including trivia nights, cocktail parties, online auctions and raffles the 2023 graduates raised \$19,545 for The Indigenous Literacy Foundation.

Fundraising: Colin Biggers & Paisley Christmas Appeal

The Colin Biggers & Paisley Foundation's 2023 Christmas appeal also raised \$18,328 for The Indigenous Literacy Foundation. This money was raised through our 'Final Hour Appeal', where staff choose to donate their final hour of work to our major charity partner; and through our Christmas gift donations, where staff elect to donate the value of their staff Christmas gift, instead of receiving it themselves.



Indigenous Literacy Foundation

In FY2023/24 Colin Biggers & Paisley Foundation launched a major 2-year partnership with The Indigenous Literacy Foundation, a community-led organisation that works to ensure access to culturally appropriate literacy materials for Aboriginal and Torres Strait Islander children in remote communities across Australia.

To help support The Indigenous Literacy Foundation's work, Colin Biggers & Paisley is providing a range of pro bono legal services, donations, fundraising, employee contributions, in-kind support and volunteering. During the partnership, our staff have the opportunity to contribute to equity of opportunity for all Aboriginal and Torres Strait Islander children, ensuring they have future choice in education, health and wellbeing.

In FY2023/24 a total of \$38,583 was raised and donated to The Indigenous Literacy Foundation, along with four hours of pro bono services valued at \$2,050.



Marrickville Legal Centre - Lawyer Secondments

"My secondment at Marrickville Legal Centre (MLC) was immersive and transformative. I attended MLC three days a week, working alongside other MLC lawyers to deliver frontline services to clients seeking legal advice, including tenancy law, employment law, criminal law, civil law, family law and insurance law. MLC's client base ranges from young people to the elderly, with many clients being particularly vulnerable. This experience taught me the importance of connecting with clients beyond their legal issues and understanding their backgrounds to deliver advice tailored to their unique circumstances. Witnessing the direct impact my advice had on the client's lives gave my role as a lawyer a renewed sense of purpose and meaning.

"As part of my secondment, I attended Burwood Local Court with MLC each Thursday for Apprehended Violence Order (AVO) list days. We provided a duty lawyer service, advising clients before their hearings. These clients typically faced charges such as drug possession, affray or common assault, and often had AVOs against them. Whilst challenging at times, this experience developed my core legal skills, requiring me to set aside subjective feelings and provide impartial advice based on the facts. It also taught me advocacy skills as I appeared before the Magistrate on behalf of particularly vulnerable clients who were unable to self-advocate.

"At times, my experience was emotional and confronting. Hearing clients' stories taught me invaluable skills, both as a lawyer and as a human being. It emphasised the importance of listening and being compassionate, while also being a strong, reliable figure for clients.

"Overall, my time at MLC was eye-opening and has shaped the lawyer I am today."

Refugee Legal

The Colin Biggers & Paisley Foundation works closely with Refugee Legal, Australia's largest provider of free specialist legal assistance fighting for the rights of people seeking asylum, refugees and disadvantaged migrants.

Since 2021 a total of 28 lawyers and nonlawyers from Colin Biggers & Paisley have volunteered with Refugee Legal ensuring access to justice and assistance with protection claims for Refugee Legal clients. Our lawyers have assisted asylum seekers through various Refugee Legal Clinics, including:

- Fast-Track Clinic
- Temporary Protection Visa Clinic
- Safe Haven Enterprise Visa Conversion Clinic
- Afghanistan Clinic
- Ministerial Intervention Clinic
